CHAP. 12

Chapter 9.

RESOLVE, Providing for a State Pension for Charles A. Frohock of Lincolnville.

Charles A. Frohock, pension granted to. Resolved: That a pension of \$10.00 per month be, and hereby is, granted to Charles A. Frohock, of Lincolnville, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.

Approved March 1, 1933

Chapter 10.

RESOLVE, Providing for a State Pension for Emma C. Weeks of Sidney.

Emma C. Weeks, pension provided for. Resolved: That a pension of \$30.00 per month be, and hereby is granted to Emma C. Weeks, of Sidney, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.

Chapter 11.

RESOLVE, in Favor of George L. Page of Orland, to Reimburse Him for Loss and Damage to Property in the Construction of a State Road in the Town of Orland.

George L. Page, compensated. Resolved: That there be and hereby is, appropriated, the sum of \$300 to be paid to George L. Page of Orland. This amount is a final settlement of all claims against the state and highway department for damages to his different properties located in the town of Orland.

This money is to be paid from the highway funds.

Chapter 12.

RESOLVE, Authorizing the Commissioner of Health and Welfare to Convey and Acquire Property.

Sale of realty of school for the deaf authorized. Resolved: That the

commissioner of health and welfare be, and hereby is, authorized, to convey the interest of the state in the real and personal property used in connection with the school for the deaf, subject to the approval of the governor and council, and in exchange therefor, or after any such sale for cash, to acquire other and different real and personal property in place thereof, subject to the same approval and within the limits of the city of Portland.

Chapter 13.

RESOLVE, Regulating Fishing in Quimby, Round, Haley and Ross Ponds.

Fishing in Quimby, Round, Haley and Ross ponds regulated. Resolved: That the commissioner of inland fisheries and game is hereby directed to close Quimby, Round, Haley and Ross Ponds, in the town of Rangeley in Franklin county to all fishing except fly fishing with a daily bag limit of 6 fish per person under the rules and regulations. No trout less than 8 inches or salmon less than 14 inches shall be killed.

Chapter 14.

RESOLVE, Relating to Fishing in McCoslin Brook and Turtle Pond Brook.

McCoslin Brook and Turtle Pond Brook, opened to fishing. Resolved: That the commissioner of inland fisheries and game is hereby directed to open to fishing under the general law McCoslin Brook and Turtle Pond Brook, both tributaries of Wight's Pond, in Penobscot, under the rules and regulations of the department.

Approved March 1, 1933

Chapter 15.

RESOLVE, Relating to Fishing in Whitney Brook.

Whitney Brook opened to fishing. Resolved: That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation opening to fishing under the general law Whitney brook, or Beaver Dam brook, so-called, in the towns of Island Falls and Dyer Brook.
