## Chapter 20.

### RESOLVE, Relating to the Taking of Smelts from Certain Waters of Penobscot Bay, Blue Hill Bay and Union River.

Smelt fishing in certain tidal waters, regulated. Resolved: That the commissioner of sea and shore fisheries is hereby directed to issue a rule and regulation forbidding the use of seines or gill nets, or taking smelts in any other way than with hook and line, between November 1st and April 1st of each year in certain waters of Penobscot bay, Eggemoggin Reach, Bluehill bay and Union river; beginning at Dice's Head, at Castine and extending in a direct line to a point one-half mile southwest of the most westerly point of Cape Rosier, thence in a direct line easterly to Two Bush Ledge Buoy, thence in a direct line northeasterly to the eastern Triangle Ledge Buoy, thence following center line of Eggemoggin Reach southeasterly to Channel Rock Ledge Buoy, thence in an easterly direction to Mahoney's Ledge Buoy, thence in a direct line northeasterly to the northwestern end of Tinker's Island, thence in a direct line northeasterly to the southwest point of Oak Point located on east side of Union river, including all harbors, inlets and tributaries on the northerly side of designated line; meaning and intending that this rule and regulation shall supersede all existing private and special laws and rules and regulations that now apply to the above described territory. This rule and regulation shall not apply to the catching of smelts in traps set for herring.

## Chapter 21.

### RESOLVE, Restricting the Taking of Smelts in Panther Pond, in the County of Cumberland.

Smelt fishing in Panther pond, regulated. Resolved: That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation prohibiting the taking of smelts more than 6 inches in length by any means in Panther pond, in the county of Cumberland, or any of the tributaries of said pond; except such smelts may be taken in the daytime with single hook and line in the ordinary manner.
