Chapter 40.

RESOLVE, Relating to Fishing in Pleasant Pond.

Fishing prohibited in outlet of Pleasant pond. Resolved: That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation closing that part of Pleasant pond in the town of Turner lying south of a row of stakes which are situated approximately 5 rods north of the outlet of the stream.

Chapter 41.

RESOLVE, Relating to Fishing in Sandy Stream.

Sandy stream closed to fishing. Resolved: That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation closing to all fishing that part of Sandy stream in Penobscot county below the mouth of Togue stream.

Chapter 42.

RESOLVE, Providing for the Payment of Certain Amounts Due Exhibitors at the Maine State Agricultural Society in Nineteen Hundred Thirty-two, on Account of State Stipend.

Maine State Agricultural Society, state stipend. Resolved: That there be paid to Turner Grange and 65 other exhibitors constituting the Maine State Agricultural Society, in 1932 the sum of \$3000 being the amount the state of Maine would have paid said society had said society complied with all provisions of section 25 of chapter 39 of the revised statutes; said sum to be distributed among such exhibitors by the commissioner of agriculture in accordance with the amounts awarded them in premiums upon live stock, agricultural and domestic products but not paid by said society.

Chapter 43.

RESOLVE, in Favor of Procuring Testimonials for the Purpose of Marking the Unmarked Graves of the Soldiers of the Revolutionary War.

Marking of graves of soldiers of the Revolutionary War; appropriation

CHAP. 46

for. Resolved: That the sum of \$150 be and hereby is appropriated for the fiscal year ending June 30, 1934, for the purpose of procuring testimonials to be used in marking the unmarked graves of the soldiers of the Revolutionary War, and be it further

Resolved: That with the approval of the governor and council, said sum shall be paid into the treasury of the "Sons of the American Revolution", with which they are hereby authorized to procure and distribute such number of markers as may, from time to time, be required for the purposes herein specified.

Chapter 44.

RESOLVE, Regulating Ice Fishing in Tacoma Lakes.

Ice fishing in Tacoma lakes regulated. **Resolved:** That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation opening Tacoma lakes in Litchfield in Kennebec county, to ice fishing for white perch and pickerel only, on Mondays and Thursdays of each week between January 1 and March 15, both days inclusive.

Chapter 45.

RESOLVE, Relative to the Open Season on Brooks in the Town of York in York County.

Fishing in certain brooks in town of York, regulated. **Resolved:** That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation extending the open season for fishing on the fresh water brooks in the town of York, in the county of York, to conform to the general law of the state.

Chapter 46.

RESOLVE, Regulating the Fishing in Milliken's Mill Pond in the Town of Old Orchard Beach in the County of York.

Regulating the fishing in Milliken's Mill pond. **Resolved:** That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation prohibiting fishing in Milliken's Mill pond and the tribu-
