Chapter 93.

RESOLVE, in Favor of Charles Hadley, of West Sumner.

Charles Hadley compensated for damage done by relocation of road. Resolved: That there be, and hereby is, appropriated, the sum of \$100 to be paid to Charles Hadley, of West Sumner, to compensate him for damage done to his property by the relocation of a highway; said sum to be paid from the general highway funds.

Chapter 94.

RESOLVE, to Reimburse the City of Bath, for Support and Burial Expenses of Mrs. William A. Griffin, Formerly a Resident of Malaga Island.

City of Bath reimbursed. Resolved: That there be, and hereby is, appropriated to be paid to the city of Bath, the sum of \$92.50 to reimburse said city for money expended for the support and burial expenses of Mrs. William A. Griffin, formerly a resident of Malaga Island.

Chapter 95.

RESOLVE, Relating to Ice Fishing in No Name Pond.

No Name pond closed to ice fishing. Resolved: That the commissioner of inland fisheries and game is hereby directed to issue a rule and regulation closing to ice fishing No Name pond, in Lewiston.

Approved March 23, 1933

Chapter 96.

RESOLVE, Relating to Fishing in the Little Magalloway River.

Entrance to Azischohos lake designated. Resolved: The commissioner of inland fisheries and game is authorized to establish a high water mark point of Azischohos lake on the Little Magalloway river and place 2 red posts on opposite banks at said point; said red posts shall designate the point on the Little Magalloway river below which it shall be legal to fish in accordance with the laws governing fishing in Azischohos lake.
