### Chapter 136.

**RESOLVE, Providing for an Increase in State Pension for Ellen Bird, of Farmingdale.**

**Pension provided for Ellen Bird. Resolved:** That a pension of \$12 per month be, and hereby is, granted to Ellen Bird, of Farmingdale, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature, and shall be in lieu of the state pension which she is now receiving.

### Chapter 137.

**RESOLVE, Providing for a State Pension for George L. Harvey, of Belfast.**

**George L. Harvey, pension for. Resolved:** That a pension of \$12 per month be, and hereby is, granted to George L. Harvey, of Belfast, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.

### Chapter 138.

**RESOLVE, Providing for a State Pension for Hannah L. Batchelor, of Belfast.**

**Hannah L. Batchelor; pension for. Resolved:** That a pension of \$12 per month be, and hereby is, granted to Hannah L. Batchelor, of Belfast, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.
