Chapter 139.

RESOLVE, Providing for an Increase in State Pension for Kate Bird, of Farmingdale.

Kate Bird; pension for. Resolved: That a pension of \$12 per month be, and hereby is, granted to Kate Bird, of Farmingdale, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and shall continue until otherwise provided by the legislature, and shall be in lieu of the state pension which she is now receiving.

Chapter 140.

RESOLVE, Providing for an Increase in State Pension for Hannah C. McLaughlin, of Farmingdale.

Pension provided for Hannah C. McLaughlin. Resolved: That a pension of \$12 per month be, and hereby is, granted to Hannah C. McLaughlin, of Farmingdale, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature, and shall be in lieu of the state pension which she is now receiving.

Chapter 141.

RESOLVE, Providing for a State Pension for Fred E. Stevens, of Chelsea.

Pension provided for Fred E. Stevens. Resolved: That a pension of \$15 per month be, and hereby is, granted to Fred E. Stevens, of Chelsea, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.

Chapter 142.

RESOLVE, Providing for a Pension for Laura Witham, of Lisbon.

Laura Witham; state pension. Resolved: That a pension of \$12 per month be, and hereby is, granted to Laura Witham, of Lisbon, to be paid

quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1, 1933, and continue until otherwise provided by the legislature.

Chapter 143.

RESOLVE, in Favor of a Pension for Richard T. Kensell, of Alna.

Richard T. Kensell; state pension. Resolved: That there be, and hereby is, granted to Richard T. Kensell, of Alna, a pension of \$20 per month to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue for 2 years.

Chapter 144.

RESOLVE, Providing for a State Pension for Fred Witham, of Washington.

Fred Witham; state pension. Resolved: That a pension of \$8 per month be, and hereby is, granted to Fred Witham, of Washington, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.

RESOLVE, Providing for a State Pension for Frank Cunningham, of Washington.

Frank Cunningham; state pension. Resolved: That a pension of \$8 per month be, and hereby is, granted to Frank Cunningham, of Washington, to be paid quarterly from the fund for pensions for soldiers and sailors and their dependents. Said pension shall begin July 1st, 1933, and continue until otherwise provided by the legislature.
