### Chapter 197.

**RESOLVE**, for the Laying of the County Taxes for the Year Nineteen Hundred Thirty-four.

County taxes apportioned. Resolved: That the sum annexed to the counties in the following schedule is hereby granted as a tax on each county respectively to be appropriated, assessed, collected and applied to the purpose of paying the debts and necessary expenses of the same and for other purposes of law, for the year nineteen hundred and thirty-four.

## Chapter 199.

### RESOLVE, in Favor of the State Museum.

State museum, appropriation for. Resolved: That the sum of \$5000 is hereby appropriated, \$2500 for the fiscal year ending June 30, 1934 and \$2500 for the fiscal year ending June 30, 1935 for the care of the state museum, and for the repair and purchase of new display cases; and further resolved that the care and maintenance of the museum remain in the control of the department of inland fisheries and game during the period of this resolve.

## Chapter 200.

### RESOLVE, in Favor of Township No. 10.

Appropriation for road in township No. 10. Resolved: That there be, and hereby is, appropriated, in favor of township No. 10 in Hancock county, \$3000 for the fiscal year ending June 30, 1934, to aid in repairing and building the road leading from Franklin to Cherryfield, in Black's woods, so-called, beginning at the eastern end of Fox pond and extending easterly to the top of Catherine's hill so-called; to be expended under the direction of the state highway commission from the general highway fund.
