EXCLUSION FROM SCHOOL ACCOUNT OF FIFTH OR DISEASE. 207 CHAP. 10

Chapter 8.

AN ACT Relating to Admission to Normal Schools.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 19, § **188, as amended; further amended.** Section **188** of chapter 19 of the revised statutes, as amended, is hereby further amended to read as follows:

'Sec. 188. Applicants for admission, qualifications; tuition. Applicants for admission shall be 17 years of age, and shall signify their intention to become teachers. The trustees shall charge \$100 for tuition to non-residents of the state, and \$50 for tuition to residents of the state. They may permit not exceeding 10% of the enrolment of residents to pay their tuition charges at such future dates as the trustees may determine.'

Chapter 9.

AN ACT Relating to the Powers and Duties of Superintendents. Be it enacted by the People of the State of Maine, as follows:

R. S., c. 19, § 70, $\|$ (e), amended. Paragraph (e) of section 70 of chapter 19 of the revised statutes is hereby amended to read as follows:

'(e) Shall nominate teachers; election to be approved by committee. He shall nominate all teachers subject to such regulations governing salaries and the qualifications of teachers as the superintending school committee shall make, and upon the approval of nominations by said committee he may employ teachers so nominated and approved. Provided, in case the superintendent of schools and the superintending school committee fail to legally elect a teacher, the commissioner of education shall have authority to appoint a substitute teacher who shall serve until such election is made.'

Chapter 10.

AN ACT Relating to the Exclusion of Pupils from School on Account of Filth or Disease.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 19, § 60, amended. Section 60 of chapter 19 of the revised statutes is hereby amended to read as follows:

'Sec. 60. Exclusion of pupils from school on account of filth or disease.
