Chapter 16.

AN ACT Relating to Number of Lines Permitted in Ice Fishing.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 38, § 28-A, additional. Chapter 38 of the revised statutes is hereby amended by adding thereto the following section, to be numbered 28-A:

'Sec. 28-A. Ice fishing regulated. Any person legally licensed may fish through the ice in the daytime with not more than 5 set lines, when under the immediate supervision of the person fishing, in any waters that are open to ice fishing and in the nighttime for cusk, in any waters open for cusk fishing in the nighttime. Any person who violates the provisions of this section shall be subject to the provisions of section 107.'

Sec. 2. Repealing clause. All acts or parts of acts inconsistent herewith are hereby repealed.

Chapter 17.

AN ACT Amending the Duty of Innkeepers.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 36, § 5, amended. Section 5 of chapter 36 of the revised statutes is hereby amended to read as follows:

'Sec. 5. Duty of innkeepers to provide entertainment. Every innkeeper shall, at all times, be furnished with suitable provisions and lodging for strangers and travelers, and with stable room, hay, and provender for their horses and cattle; and with pasturing, if it is required by the terms of his license; and he shall grant such reasonable accommodations as occasion requires, to strangers, travelers, and others.'

Chapter 18.

AN ACT Relating to the Society of Friends.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 20, § 23, repealed. Section 23 of chapter 20 of the revised statutes is hereby repealed and the following enacted in place thereof:

CHAP. 19

'Sec. 23. Trustees to hold grants as corporations. The trustees of each monthly meeting of the Religious Society of Friends (or Quakers) are so far corporations as to take and hold, in succession, all grants and gifts of real, personal, or mixed estate made to said meetings or to them, for the use of their monthly meetings, the preparative meetings constituting them, or the poor thereof.

Also to take and hold as aforesaid, all grants and gifts of real, personal and mixed estate made to said monthly meetings or the trustees thereof for the use of quarterly meetings of said Religious Society of Friends (or Quakers) for their use, or the use of the poor thereof. Said trustees shall hold, manage and convey all such estate according to the terms and conditions on which it was granted or given. They may sue in their names as such trustees, for any right, title or interest to which said meetings or their trustees are entitled.

Provided, however, that the annual income therefrom, to any one meeting, for the uses specified shall not exceed \$5000. These powers may be enlarged, restrained or repealed by the legislature.'

Chapter 19.

AN ACT Creating Separate Polling District for Rockwood, an Unorganized Place in the County of Somerset.

Be it enacted by the People of the State of Maine, as follows:

Rockwood to have separate polling place. The municipal officers of Jackman plantation are hereby directed to establish a polling place at Rockwood an unorganized place in the county of Somerset for all state and national elections, including primary elections, at which polling place all residents of unorganized places entitled to vote in Jackman plantation may cast their ballots under the conditions provided in this act. The municipal officers shall prepare a separate list of such voters resident in unorganized places who are entitled to vote in Jackman plantation as may request the privilege of voting at Rockwood at the time they qualify as voters in Jackman under section 76 of chapter 8 of the revised statutes, and all persons whose names are so included in said list shall be entitled to vote at said polling place in Rockwood instead of at Jackman.

The conduct of elections at said polling place shall be the same as in towns having separate polling districts, and all the provisions of the revised statutes with respect to separate polling districts in towns are hereby made applicable to said polling place at Rockwood as though the same were located within the territorial limits of Jackman plantation, and the
