CHAP. 184

'Sec. 233-B. **Special provision.** Any member of the state highway police who, on the effective date of this act shall have attained the age of 65 years and shall have been so employed for not less than 12 years may be retired on half pay, as pension, upon recommendation of the chief of the state highway police.'

'Sec. 233-C. **Provision for payment.** Funds for the payment of the retirement pay of state highway police officers shall be included in the annual budget of the state highway police department and the amounts necessary to pay such retirement pay shall be in addition to the regular appropriation for the support of the department. Any person convicted of a felony while receiving a pension under the provisions of this section shall forfeit such pension.'

Chapter 183.

AN ACT Relative to the Suspension of Bounties on Porcupines and Hedgehogs.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 38, § 78, suspended. The provisions of section 78 of chapter 38 of the revised statutes, relating to the bounties on porcupines and hedgehogs, are hereby suspended until June 30, 1937.

Sec. 2. P. L., 1931, c. 249, suspended. The provisions of chapter 249 of the public laws of 1931, relating to payment of bounties on porcupines, are hereby suspended until June 30, 1937.

Chapter 184.

AN ACT Relating to Game Preserves at Back Bay, Portland.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 38, § 85, amended. Section 85 of chapter 38 of the revised statutes, as amended, is hereby amended to read as follows:

'Sec. 85. **Bird hunting in Back Bay, regulated.** No person shall at any time hunt, chase, catch, kill or destroy any water fowl or any other wild bird in Back Bay, so-called, in Portland, in the county of Cumberland, above the Grand Trunk railway bridge or within the area enclosed by a boundary line drawn as follows: beginning at Fish Point at the easterly end of the Eastern Promenade in the city of Portland, thence extending

about northeasterly to Pomeroy's Rock, thence about northeasterly to Mackworth or Half-way Rock southerly of Mackworth or Mackey Island, thence in a northerly direction to a point marked by a buoy 1000 feet from the most easterly point of Mackworth Island, so-called, thence in a ~~northerly direction to the center of the dam at Moody's Creek so called~~ ~~on~~ northwesterly direction to a point where the bridge to Mackworth Island touches the Falmouth shore, thence about southwesterly along the shore of the town of Falmouth to Mackworth or Mackey point, thence about southwesterly along the easterly side of Martin Point bridge to the shore of East Deering (United States Marine Hospital) Portland, thence about southwesterly and southerly along said East Deering shore to the Grand Trunk bridge, thence along the easterly side of said Grand Trunk bridge to the shore of the Eastern Promenade, Portland, thence about southerly along said shore of the Eastern Promenade to the said Fish Point, the point begun at. No person shall have in possession at any time any water fowl or any other wild bird or any wild animal, or part thereof, taken in violation of any provision of this section. Whoever violates any provision of this section shall be punished by a fine of not less than \$10, nor more than \$40 and costs, for each offense.'

Chapter 185.

AN ACT Relative to Resident Fishing and Hunting Licenses.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 38, § 19, amended. Section 19 of chapter 38 of the revised statutes is hereby amended so that the 1st paragraph thereof shall read as follows:

'No resident of the state over ~~16~~ 18 years of age and no non-resident over the age of 10 years shall fish in any inland waters of the state except in accordance with the following provisions:'

Sec. 2: R. S., c. 38, § 19, ¶ 2, amended. Sub-paragraph 2 of section 19 of chapter 38 of the revised statutes is hereby amended, to read as follows:

'(2) Each resident of the state and each non-resident shall purchase from the commissioner or his authorized agent the written license of the commissioner which shall be kept upon the person while fishing or transporting fish, and shall be exhibited to any warden, employee of this department, or guide upon request. All employees and soldiers regularly employed at the National Soldiers' Home shall be and hereby are, classified as residents of this state for the purpose of obtaining fishing licenses, and shall pay the same fees and be held to the same laws, rules and regulations
