dealers, dealers in old gold, silver and precious metals, hawkers and peddlers, employment agencies, itinerant vendors, public automobiles, taxicabs and motor busses, public wagons and trucks, amusements, exhibitions and performances, theaters, moving picture houses, inns, victualers, pawn brokers, lodging houses of 10 lodging rooms or more, public shooting galleries, the manufacture, storage, sale, disposition and use of fireworks, dance halls, circuses, and the erection and maintenance of signs, flags, banners, awnings, marquees and all other things within the limits of the sidewalks, roads, ways and streets of said city, and no such objects placed within said limits in accordance with such ordinances shall be deemed defects in such sidewalks, roads, ways and streets.

Sec. 2. Inconsistent acts repealed. All acts, parts of acts, ordinances, parts of ordinances, and provisions of charters, inconsistent with the provisions hereof, are hereby repealed, except that all ordinances or parts of ordinances hereby repealed, shall remain in force for the trial and punishment of all past violation of them, and for the recovery of penalties and forfeitures already incurred, and for the preservation of all rights and remedies existing by them and so far as they apply, to any office, trust, proceeding, right, contract or event, already affected by them.

Chapter 15.

AN ACT to Validate the Organization of Caribou Water, Light and Power Company, and to Enlarge its Purposes.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Ratification. The organization of Caribou Water, Light and Power Company under the provisions of sections 94 and 105 of chapter 51 of the revised statutes of 1883, the original issuance of its stock and the election of its officers are hereby ratified, confirmed and made valid in all respects.

Sec. 2. Extension of service. Said Caribou Water, Light and Power Company is hereby authorized to extend its mains, services and transmission lines into the towns of New Sweden, Stockholm, Woodland, Perham and Connor, and into Westmanland Plantation, and to carry on business as a public utility supplying water, light and power in said towns and plantation. Said Caribou Water, Light and Power Company is hereby also authorized, subject to the approval of the public utilities commission, to acquire by purchase or otherwise all the property and assets of Limestone Water and Sewer Company, and upon so doing to carry on business now carried on by said Limestone Water and Sewer Company and to exercise

its franchises. Nothing in this section contained shall be deemed to affect the provisions of sections 3 and 4 of chapter 68 of the revised statutes, or to enable said Caribou Water, Light and Power Company to make, generate, sell, distribute or supply electricity or furnish water in said towns or plantation, or in any of them, whether in competition with any other public utility or otherwise, without first obtaining the consent of the public utilities commission.

Sec. 3. Increase of capital stock, authorized. Said Caribou Water, Light and Power Company is hereby authorized to increase its capital stock to \$300,000.

Chapter 16.

AN ACT to Validate the Organization of Colby Light & Power Company, and the Issuance of Its Stock.

Be it enacted by the People of the State of Maine, as follows:

Ratification. The organization of Colby Light & Power Company in 1921 under the general laws of Maine, the original issuance of its stock, and the election of its officers are hereby ratified, confirmed and made valid in all respects.

Chapter 17.

AN ACT to Incorporate the Town of Jonesport School District.

Emergency preamble. Whereas, since the high school building in the town of Jonesport, in Washington county, burned on December 22, 1933, it has been necessary to continue classes in an abandoned school house, and the Knights of Pythias Hall, where there is not sufficient room, and where the lighting and heating is inadequate, which is a dangerous condition to the lives and health of the pupils of said school, and

Whereas, it is imperative that action be taken at the earliest possible moment to relieve this dangerous condition, and so that application can be made to the Federal Public Works Administration for a grant and a loan, and

Whereas, construction should be commenced immediately, and

Whereas, in the opinion of the legislature, these facts render the immediate passage of this act necessary for the preservation of the public peace, health and safety, and constitute an emergency within the meaning of section 16 of Article XXXI of the constitution; now, therefore,
