CHAP. 31

Chapter 28.**RESOLVE, Relative to Fishing in the River Between Mooselucmeguntic Lake and Upper Richardson Lake.**

Fishing in river between Mooselucmeguntic lake and Upper Richardson lake, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening Upper Dam pool and the river extending between Mooselucmeguntic lake and Upper Richardson lake, to fishing, from sunrise to 1 hour after sunset of each day.

Approved March 8, 1935.

Chapter 29.**RESOLVE, Relating to Muskrats in Morrill Mill Pond.**

Closed season on muskrats in Morrill Mill pond. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation declaring a closed season on muskrats in Morrill Mill pond, in the county of Waldo, for a period of 2 years.

Approved March 8, 1935.

Chapter 30.**RESOLVE, in Favor of William C. Boyles, of Castle Hill.**

William C. Boyles; compensated for damage done by bears. Resolved: That there be, and hereby is, appropriated, the sum of \$120 to be paid to William C. Boyles, of Castle Hill, to compensate him for damage done to his bees and crops by bears; said sum to be paid from the funds of the department of inland fisheries and game.

Approved March 15, 1935.

Chapter 31.**RESOLVE, in Favor of Samuel Dana, Representative of the Passamaquoddy Tribe of Indians.**

Appropriation for Indians' representative. Resolved: That there be, and hereby is, appropriated, to be paid to Samuel Dana, representative of the Passamaquoddy tribe of Indians to the 87th legislature, the sum of \$200 for attendance, and \$44 for mileage; said sums to be paid from the appropriation for legislative expenses.

Approved March 15, 1935.
