Chapter 86.

RESOLVE, Relative to Smelt Fishing in China Lake.

Smelt fishing in China lake, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation establishing a bag limit on smelts of 25 per person per day in the waters of China lake, in the towns of China and Vassalboro.

Approved March 30, 1935.

Chapter 87.

RESOLVE, Relating to Fishing in North Pond.

Fishing in North pond, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening North pond in Elliottsville plantation to ice fishing for all fish, except bass, during the months of February, March and April.

Chapter 88.

RESOLVE, Authorizing the Forest Commissioner to Sell Lands in Penobscot County.

Sale of certain lands authorized. Resolved: That the forest commissioner be, and hereby is, authorized to sell and convey to Hollis Madden, of Milford, 25 acres in Number 1, North Division, Penobscot county, for the amount due to the state for taxes and costs.

Chapter 89.

RESOLVE, Relative to the Taking of Smelts for Food Purposes From Crooked and Songo Rivers and Batchelder Brook.

Smelt taking in Crooked and Songo rivers, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed

to issue a rule and regulation opening that portion of the Crooked and Songo rivers in the towns of Naples and Casco, and Batchelder brook in the town of Sebago, which are now open for the taking of smelts under 6 inches in length for live bait, to the taking of smelts under 6 inches in length with a dip-net for food purposes with a daily bag limit of 3 quarts per person with a season limit of 12 quarts; and the commissioner may promulgate such further rules and regulations as he may deem necessary to carry the provisions of this resolve into effect and prevent the abuse of the privileges granted thereunder.

Chapter 90.

RESOLVE, Regulating Ice Fishing in Pleasant, Mud and Horseshoe Ponds, Cobbosseecontee Stream and the Tacoma Chain of Lakes in the Counties of Kennebec and Sagadahoc.

Ice fishing in Pleasant, Mud and Horseshoe ponds, Cobbosseecontee stream and the Tacoma chain of lakes, regulated. **Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening Pleasant and Mud ponds in the counties of Kennebec and Sagadahoc, and Horseshoe pond and Cobbosseecontee stream below Horseshoe pond to fishing through the ice under the general law and the Tacoma chain of lakes in Kennebec county to fishing through the ice for white perch and pickerel only on Thursdays and Saturdays of each week from February 1st to March 15th.

Chapter 91.

RESOLVE, Relative to the Digging of Clams in Mount Desert.

Digging of clams in Mount Desert, regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to issue the following rule and regulation:

'It shall be unlawful for any person not a resident of or riparian owner in the town of Mount Desert, in the county of Hancock, to dig clams within the limits of said town. Any person residing therein or the riparian owner of any clam flats may take therefrom not exceeding 5 bushels of clams in 1 day. Any person taking clams contrary to the provisions hereof shall be punished for each offense by a fine of not more than \$25, or by imprisonment for not more than 30 days, or by both such fine and imprisonment.'
