## CHAP. 59

missioner to inspect game shipments, and having an official transportation tag attached thereto, after being identified by said transportation agent or game inspector as the holder of said license. Provided, further, it shall be unlawful for any person to have in possession or transport at any time any wild hares or rabbits taken in closed season or by any method or with any device prohibited by this section.'

## Chapter 58

### AN ACT Relative to Game Preserve in the Towns of Limington and Hollis in York County.

*Be it enacted by the People of the State of Maine, as follows:*

Game preserve in the towns of Limington and Hollis, extended. The game preserve established in the towns of Limington and Hollis in York county by chapter 135 of the public laws of 1935 is hereby extended for a period of 2 years.

## Chapter 59

### AN ACT Relative to Game Preserve in York County.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 38, § 89, additional. Section 89 of chapter 38 of the revised statutes, as revised, is hereby amended by adding at the end of section 89, a new section to be numbered section 89-A, and to read as follows:

'Sec. 89-A. Wells and York game preserve, established. No person shall, except as herein provided, at any time, hunt, pursue, shoot at, molest or kill any wild animal or any game or wild bird within the following described territory situated in the towns of Wells and York in York county; beginning at a point on highway No. 1 where the Agamenticus road meets said highway No. 1 in the town of Wells, thence southwesterly along said Agamenticus road to the logging road, so-called, in the town of York, thence westerly and northerly along said logging road to the Ogunquit-North Berwick road, thence easterly along said Ogunquit-North Berwick road to highway No. 1 in the town of Wells, thence southerly along highway No. 1 to the point of beginning in the town of Wells.
