vided further, it shall be unlawful to use or have in possession any firearms except a 22 caliber pistol while hunting as provided in this paragraph and not more than 2 raccoons shall be taken by any 1 party in any 1 night.'

Chapter 155

AN ACT Relating to Enforcement of Divorce Decrees.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 73, amended. Chapter 73 of the revised statutes is hereby amended by adding after section 9, the following section, to be numbered 9-A:

'Sec. 9-A. Payment of alimony. Pending a petition to enforce a decree of alimony or a decree for payment of money instead thereof, the court may order the husband to pay to the clerk of the court, for the wife, sufficient money for the prosecution thereof, upon default of which order execution may issue as in actions of tort. When the husband is committed to jail on execution issued upon decree of alimony or for payment of money instead thereof, the county having jurisdiction of the process shall bear the expense of his support.'

Chapter 156

AN ACT Relating to a State Geologist.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 49, § 53, amended. Section 53 of chapter 49 of the revised statutes, as amended by chapter 250 of the public laws of 1931, is hereby further amended to read as follows:

'Sec. 53. Compensation; expenses. The state geologist shall be paid ~~ten dollars per day and expenses while actively engaged in the performance of his duties~~ receive an annual salary of \$1000 for each of the fiscal years ending June 30, 1938 and June 30, 1939 and such expenses as may be approved by the governor and council. He may employ assistants, purchase material and publish documents for which the state shall pay out of funds provided for the department.'
