## Chapter 157

### AN ACT Relating to the Maine State Planning Board.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. P. L., 1935, c. 191, repealed. Chapter 191 of the public laws of 1935 entitled "An Act Relating to State Planning and Development" is hereby repealed.

Sec. 2. Transfer of office equipment, etc. The Maine state planning board shall turn over and deliver to the Maine development commission all office equipment, books, records, files, maps, charts, plans, data and other property owned by it on the effective date of this act.

Approved April 15, 1937.

## Chapter 158

### AN ACT Relating to Pauper Settlement.

*Be it enacted by the People of the State of Maine, as follows:*

R. S., c. 33, § 29, amended. Section 29 of chapter 33 of the revised statutes, as amended by section 27 of chapter 225 of the public laws of 1931, is hereby further amended by adding at the end thereof the following:

'When relief is given to a person having a settlement in another municipality and no legal notice of such aid has been sent to the municipality of settlement within 6 months from the time that expense has been incurred, the continuity of acquiring a settlement in the municipality furnishing such aid or relief shall not be interrupted thereby.

Notice as hereinbefore provided shall be deemed sufficient if the said notice is sent to the municipality of apparent settlement as indicated by written evidence of settlement submitted by the applicant for relief.'
