Upon receipt by the state controller of a certificate from the commissioner showing that said commissioner has received the tail of the bobcat, loupcervier or Canada lynx from the warden sent as aforesaid, said controller shall audit the claim for bounty and the same shall be paid forthwith by the treasurer of state to the claimant from fines and penalties recovered and money received, or collected under any provision of the inland fish or game laws or amendments thereof, or for sale of any seized or confiscated articles. After the foregoing appropriation has been exhausted, any further bounties shall be paid from the general appropriation of the department of inland fisheries and game, and if said appropriation is not exhausted any balance thereof shall revert to the general funds of the department of inland fisheries and game.'

... Chapter 206

AN ACT Relating to County Accounts.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. County accounting regulated. The county commissioners and county treasurers of the several counties shall keep their books and accounts on such forms and in such manner as shall be approved by the state department of audit.
- Sec. 2. Annual audit required. The state department of audit shall annually conduct an audit of the books, accounts and records of all financial transactions of the several counties of the state and a copy of such audit shall accompany the county estimates submitted to the legislature, as pro-

vided by section 67 of chapter 13 of the revised statutes, as amended by chapter 107 of the public laws of 1935, the expense of same to be paid by the counties.

Chapter 207

AN ACT Relative to Termination of Registrations of Motor Vehicles.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 29, § 65, amended. Section 65 of chapter 29 of the revised statutes, as amended by section 2 of chapter 224 of the public laws of 1931, is hereby further amended to read as follows:

'Sec. 65. Registration certificates and licenses to operate; termination of. All registrations of vehicles, all certificates of registration and number plates, and all licenses to operate motor vehicles shall terminate and become void at midnight on the 31st day of December of each year; except as provided in paragraph 2 of section 55 of this chapter; and no person shall operate any motor vehicle on or after the 1st day of January of any year unless then duly licensed to operate such vehicle for such year.'

Chapter 208

AN ACT Exempting Trucking of Farm Products and Certain Lumbering Products from the Common Carrier Law.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. P. L., 1935, c. 146, § 10, amended. That part numbered (3) of paragraph (A) of section 10 of chapter 146 of the public laws of 1935 is hereby amended to read as follows:
- '(3) while engaged exclusively in the delivery of the United States mail; while engaged exclusively in the transportation of fresh fruits and vegetables from farms to canneries, place of storage or place of shipment during the harvesting, canning or packing season; while engaged exclusively in the hauling of wood, pulpwood, logs or sawed lumber from the wood lot or forest area where cut or sawed to points within 40 miles thereof, or while hauling, within said distance, horses, crew, equipment and supplies to or from such wood lot or forest area.
