## Chapter 12

**RESOLVE, Relating to Lobster Fishing in Winter Harbor.**

Lobster fishing in Winter Harbor, regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to repeal rule and regulation numbered 5, relating to catching of lobsters.

Approved March 4, 1937.

## Chapter 13

**RESOLVE, Relating to the Taking of Clams Within the Town of Islesboro.**

Taking of clams in Islesboro, regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to issue a rule and regulation that no person, firm or corporation, except an inhabitant of the town of Islesboro, shall take more than  $\frac{1}{2}$  bushel of clams in any 1 day from within the limits of the tide-waters of the town of Islesboro. Whoever violates any provision of this resolve shall be punished by a fine of not more than \$200.

## Chapter 14

**RESOLVE, Relating to Taking of Clams in Harrington.**

Taking clams in Harrington, regulated. Resolved: That the commissioner of sea and shore fisheries be, and hereby is, directed to issue a rule and regulation forbidding any person not a resident of the town of Harrington, in the county of Washington, to dig clams for commercial purposes within the limits of said town. Any person taking clams contrary to the provisions of this rule and regulation shall be punished for each offense by a fine of not more than \$25, or by imprisonment for not more than 30 days, or by both such fine and imprisonment.

## Chapter 15

**RESOLVE, in Favor of John S. Nelson, Representative of the Penobscot Tribe of Indians.**

Appropriation for Indians' representative. Resolved: That there be, and hereby is, appropriated, to be paid to John S. Nelson, representative of the Penobscot tribe of Indians at the 88th legislature, the sum of \$200 for attendance, and \$18 for mileage; said sums to be paid from the appropriation for legislative expenses.

Approved March 6, 1937.
