## Chapter 24

### RESOLVE, Changing the Name of Greeley Pond.

Greeley pond; name changed. Resolved: That Greeley pond, so-called, located in the towns of Readfield and Mt. Vernon, shall be hereafter known as Torsey lake.

## Chapter 25

### RESOLVE, Granting Authority to the Forestry Department to Convey Certain Land.

Forestry department authorized to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey the following described lot to Alice V. Dunbar, of Sullivan, for the sum of \$65.85: 100 acres of land in township 7, South Division, Hancock county.

## Chapter 26

### RESOLVE, Granting Authority to the Forestry Department to Convey Certain Land.

Forestry department authorized to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey the following described lot to Leo M. Taylor, of Topsfield for the sum of \$69.90: 174 acres of land in township 7, range 2, north of Bingham's Penobscot purchase, Washington county.

### RESOLVE, Granting Authority to the Forestry Department to Convey Certain Land.

Forestry department authorized to sell certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey the following described lot to Alice V. Dunbar, of Sullivan, for the sum of \$10.81: 15 acres of land in township 7, South Division, Hancock county.
