## Chapter 57

**RESOLVE, Providing for a State Pension for John Mains, of York.**

**John Mains, pension for. Resolved:** That John Mains, of York, a former employee of the state highway department for 20 years, is hereby made eligible to receive a retirement pension under the provisions of sections 227-230 of chapter 1 of the public laws of 1933.

## Chapter 58

**RESOLVE, Relating to an Investigation of the Pollution of Rivers in the State.**

**Public utilities commission authorized to investigate the pollution of rivers in the state. Resolved:** That the public utilities commission be, and hereby is, authorized and directed to investigate the conditions of pollution in our rivers, as disclosed by certain surveys which have been made in the past, or such additional survey as may be in process or found necessary at the present time to carry out the intention of this resolve, and after a mature study of the problems presented by this pollution, and a review of the laws and methods used by the federal and other state governments to cope with similar problems, submit a report to the governor covering same and recommending remedial legislation if such be deemed practicable and desirable.

In conducting this investigation and study, the commission may use such powers as it now possesses for obtaining information and data.

This investigation and report shall be completed within 1 year from the effective date of this act.

**RESOLVE, Providing for the Payment of Certain Damages Caused by Protected Wild Animals.**

**Damages caused by deer and moose to automobiles; provided for. Resolved:** That there be, and hereby is, appropriated, the sum of \$2,427.11 to be paid to certain persons, the amount in the aggregate as set against the following names as a full and final settlement against the state for
