Chapter 68

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Land in Somerset County to A. L. Gaudet of Rockwood.

Forest commissioner authorized to convey state's interest in certain property. **Resolved:** That the forest commissioner as land agent, be and hereby is, authorized to convey to A. L. Gaudet of Rockwood, the interest of the state in one acre of land in lot 2, township 1, range 1, North Bingham's Kennebec purchase, Somerset county.

Chapter 69

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Property.

Forest commissioner authorized to convey state's interest in certain property. **Resolved:** That the forest commissioner as land agent, be and hereby is, authorized to convey to Sylvere Gaudet & Son of Rockwood, the interest of the state in 175 acres of land in lot 1, township 1, range 1, north of Bingham's Kennebec Purchase, Somerset county.

Chapter 70

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Land.

Forest commissioner authorized to convey certain land. **Resolved:** That the forest commissioner be, and hereby is, authorized to convey certain land to F. O. Foster of Forest City, for the sum of \$16.10:

1 acre of land in Township 9, Range 4, north of Bingham's Penobscot purchase, Washington county.

Chapter 71

RESOLVE, Relating to the Digging of Clams in Milbridge.

Making it lawful to dig and take clams in Milbridge. **Resolved:** That the commissioner of sea and shore fisheries be, and hereby is, directed to issue a rule and regulation that it shall be lawful for the citizens of the

town of Milbridge to dig and take clams for any purpose in the clam flats located in the town of Milbridge; notwithstanding any action taken by the municipal officers of said town under section 43 of chapter 2 of the public laws of 1933.

Chapter 72

RESOLVE, in Favor of Magalloway Plantation for Building a Fish Screen on Pond Brook.

Appropriation for fish screen in Magalloway Plantation. Resolved: That there be, and hereby is, appropriated, the sum of \$400 to compensate Magalloway Plantation for the building of a fish screen on Pond brook in Magalloway Plantation, provided, however, that some responsible person, corporation, or incorporated fish and game club, or the town in which the outlet of the waters above mentioned are situated, or some other town in the county of Oxford, in which said waters are situated, shall have agreed to assume all liability for the keeping of said screen at all times free from sticks, leaves and all debris, so that the same will not become clogged and prevent the free running of the water through the same.

Chapter 73

RESOLVE, in Favor of Megunticook Lake Anglers' Club.

Megunticook Lake Anglers' Club; appropriation for. Resolved: That there be, and hereby is, appropriated the sum of \$355.75 to be paid to the Megunticook Lake Anglers' Club, of Camden, being $\frac{1}{2}$ of the amount paid for materials and repair in the construction of the fish screen located in Canaan lake, also known as Megunticook lake. Said sum to be paid from the funds of the department of inland fisheries and game.

Approved April 15, 1937.

Chapter 74

RESOLVE, Regulating Deer Hunting on Swans Island in the County of Hancock.

Hunting of deer; regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation that no person shall hunt or shoot deer on Swans Island in the county of Hancock.
