## Chapter 90

**RESOLVE, in Favor of L. D. Chandler, of Boston, Massachusetts.**

L. D. Chandler, compensated. Resolved: That there be, and hereby is, appropriated the sum of \$663.16, to be paid to L. D. Chandler, engineer, of 130 Broad Street, Boston, Massachusetts, as compensation for plans, specifications and engineering services under the direction of Lieutenant-Colonel Charles W. Savage, Infantry, Maine National Guard, for reconstruction of a water system, etc., at Camp Keyes, Augusta, Maine; said sum to be paid from the appropriation of the adjutant general's department.

## Chapter 91

**RESOLVE, to Reimburse the Town of Benton, for Burial Expenses of J. Wilkes Hall, a Veteran of the Civil War.**

Town of Benton; compensated. Resolved: That there be, and hereby is, appropriated, to be paid to the town of Benton, the sum of \$100 as a full and final settlement against the state for the expenses of the burial of J. Wilkes Hall, a veteran of the Civil War; said sum to be paid from the general state funds.

Approved April 17, 1937.

## Chapter 92

**RESOLVE, Reimbursing the Town of Stonington, for Support of Harry Taylor.**

Town of Stonington; reimbursed. Resolved: That there be, and hereby is, appropriated, in favor of the town of Stonington, the sum of \$478.32 as a full and final settlement against the state for moneys expended for aid to Harry R. Taylor, a veteran of the World War; said sum to be paid from the general state funds.

Approved April 17, 1937.

## Chapter 93

**RESOLVE, Bonus Granted to John Charles Maher, of Old Town.**

John Charles Maher granted state bonus. Resolved: That there be, and hereby is, appropriated, \$100 to be paid to John Charles Maher, of Old Town, as his World War bonus; said sum to be paid from the general state funds.
