FOREWORD TO CROSS REFERENCE TABLES

These tables purport to show what sections of the statutes and public laws have been affected by the public laws since the 1930 revision.

They are cumulative; showing the 1931 changes in one column, the 1933 in another, the 1935 and the 1937 in another. All direct amendments are accurately shown. Indirect amendments such as those made by the Code are not completed. The Code made so many changes by implication that it is impractical to attempt to show them.

Chapters 1 and 2 of the public laws of 1933 were revision bills changing the wording and arrangement of the statutes to correspond with the intent and effect of the Code upon the law relating to health and welfare and sea and shore fisheries. The old law had been so affected that it was necessary to repeal it and re-write the whole set-up. As the new re-write had not become law, acts of the 86th legislature amending health and welfare and sea and shore fisheries law had to be drawn to amend the old law. Actually they were amendments of the new public laws which were passed at the same session.

The location in the revision of the section affected will be indicated in the column designated "New Reference". Any of the 1933 laws and later laws that are inconsistent with the provisions of chapter 1 or 2 supersede them to the extent of their inconsistency.

The allocation of new section numbers in the statutes except when made by the legislature is only temporary and shows their probable location only.

Extra tables have been made showing the sources of the law in chapters 1 and 2 of 1933.

Under the column heading "How Affected", 'Add' means "Additional by". 'Rep' means "Repealed by", 'N' means "New chapter", and 'Aff.' means "Affected by".

New material has not been allocated this year, due to the fact that new revisions coming next session would complicate such allocations.
