Chapter 31

AN ACT Relative to Weekly Close Time for Salmon, Shad, Alewives, and Bass.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. L., 1933, c. 2, § 31, amended. Section 31 of chapter 2 of the public laws of 1933 is hereby amended by adding at the end thereof the following:

'This section shall not apply to the taking of salmon or bass by the ordinary mode of angling with single hook and line or artificial flies, and no person shall fish for, take, catch or kill any bass except that they may be taken in the ordinary mode of angling with single hook and line or artificial flies, in numbers not to exceed 6 per person per day.'

Sec. 2. Repealing clause. All acts or parts of acts inconsistent herewith, are hereby repealed.

Chapter 32

AN ACT Regulating Places and Time of Taking Salmon, Shad and Alewives in Certain Waters; Penalty.

Be it enacted by the People of the State of Maine, as follows:

P. L., 1933, c. 2, § 27, amended. Section 27 of chapter 2 of the public laws of 1933, as amended, is hereby further amended to read as follows:

'Sec. 27. Regulation of places and times for taking salmon, shad and alewives in certain waters; penalty. No salmon, shad, or other migratory fish shall be taken or fished for within 500 yards of any fishway, dam, or millrace; nor in the Penobscot river between the mouth of the Kenduskeag stream and the water works dam at Treat's Falls on said river, nor between the Augusta highway bridge over the Kennebec river and the Augusta dam; nor in Mill river, a tributary of Georges river, in Thomaston, Maine, between said Georges river and the old dam at head of tidewaters in said Mill river; nor any salmon 500 feet above Ferry point bridge on the St. Croix river in Calais, between the 1st days of April and November, nor in the tidal area of the Saco river between a line drawn from the easterly point of Stage Island to Sharp's Rocks, and the southerly end of the breakwaters and from said southerly end of the breakwaters to the Laconia Falls
