Chapter 237

AN ACT Relating to Children.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 129, § 34, amended. Section 34 of chapter 129 of the revised statutes is hereby amended to read as follows:

'Sec. 34. Admitting to or allowing children in disorderly house; penalty, etc. Whoever admits or allows to remain in any disorderly house, house of ill fame, gambling place, or place where intoxicating liquors are sold; or other place injurious to health or morals, owned, kept, maintained, managed or controlled by him in whole or in part, any child under the age of 16 years, shall be punished by a fine of not more than \$100, or by imprisonment for not more than 60 days. Provided, however, that a child or children under the age of 16 years may enter places where intoxicating liquor is sold when accompanied by a parent, guardian or other adult person in charge of such child or children, with the consent of the parent or guardian of such child or children.'

Chapter 238

AN ACT Amending the Law Relative to Registration of Motor Vehicles.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 29, § 1, amended. Section 1 of chapter 29 of the revised statutes as amended is hereby further amended to read as follows:

'Sec. 1. Terms defined. As used in this chapter, unless the context otherwise indicates, the word "way" includes all kinds of public ways; the word "team" and the word "vehicle" shall each include all kinds of conveyances on such ways for persons and for property, except those propelled or drawn by human power, or used exclusively on tracks; the word "trailer" shall mean any vehicle without motive power, designed for carrying persons or property and for being drawn by a motor vehicle, not operated on tracks, and so constructed that no part of its weight rests upon the towing vehicle; the word "semitrailer" shall mean any vehicle without motive power designed for carrying persons or property and for being drawn by a motor vehicle and so designed that some part of its weight and of its load rests upon or is carried by such motor vehicle, and shall include pole dollies, pole dickeys, so-called, and wheels commonly used as a support for the ends
