### Chapter 6

AN ACT Validating Certain Acts of the Norway Village Corporation.

Be it enacted by the People of the State of Maine, as follows:

Certain acts of Norway Village Corporation, validated. All acts done by the Norway Village Corporation and its officers, relating to providing for lights and lighting in the streets and ways in the village of Norway are hereby declared to be legal, valid and effective, and all contracts made by said corporation for said purposes are hereby declared to be legal, valid and effective.

Approved February 19, 1939.

### Chapter 7

AN ACT to Ratify and Make Valid the Incorporation of the Maine State
Advent Christian Conference.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Incorporation of Maine State Advent Christian Conference ratified and made valid. The incorporation of Maine State Advent Christian Conference in Biddeford, county of York, in 1910, in accordance with the provisions of the statutes of Maine in such case made and provided, under the name and title of Maine State Advent Christian Conference, is hereby ratified, affirmed and made valid, and all acts and doings of its members and officers acting as a body corporate and politic hereby are declared to be of the same full, complete and binding force and effect as such acts and doings would have been were the name of the Maine State Advent Christian Conference now on the list of corporations in the office of the secretary of state (and were the copy of the certificate of organization of said Maine State Advent Christian Conference now in the files in said office) in accordance with the provisions of the statutes of Maine in such case made and provided, on the 11th day of November, 1910, the date when the office of the secretary of state certified "that the certificate of the organization of the Maine State Advent Christian Conference, a corporation organized under chapter 57, of the revised statutes of Maine, 1903, has been filed in this office and that said corporation is duly organized according to law." The secretary of state is hereby directed to amend the list of corporations and make the necessary entries thereon relative to the aforesaid incorporation.
