Chapter 42

AN ACT Relating to Municipal Elections in Bar Harbor (formerly Town of Eden).

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1913, c. 215, repealed. Chapter 215 of the private and special laws of 1913, as amended by chapter 204 of the private and special laws of 1915, is hereby repealed.

Approved March 16, 1939.

Chapter 43

AN ACT Authorizing the Town of Island Falls to Raise Money.

Be it enacted by the People of the State of Maine, as follows:

Town authorized to raise money. The inhabitants of the town of Island Falls, at a meeting legally called for said purpose, which meeting is hereby authorized, are hereby authorized and empowered to raise money by taxation to assist in, and to be expended in, repairing and rebuilding the county road in the town of Dyer Brook, extending from state highway No. 2 to the east line of land of John H. Lane in said town of Dyer Brook; provided the town of Dyer Brook shall raise a like amount for said purpose. Said amounts so raised shall constitute a joint fund to be expended at one time for said purpose under the supervision of the selectmen of the respective towns.

Approved March 16, 1939.

Chapter 44

AN ACT to Extend the Rights, Powers and Privileges of the Sabattus Water and Sewer District.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1929, c. 48, relating to Sabattus Water and Sewer District, charter extended. The rights, powers and privileges of the Sabattus Water and Sewer District, which were granted by chapter 48 of the private and special laws of 1929, are hereby revived and extended for and during

a period of 2 years from the date when this act shall take effect; and all the rights, powers and privileges that were granted by said act shall take effect; and all the rights, powers and privileges that were granted by said act to said Sabattus Water and Sewer District may and shall be exercised in the same manner and for the same purpose as provided in said act.

Approved March 16, 1939.

Chapter 45

AN ACT to Amend the Charter of the Camden and Rockland Water Company.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1885, c. 522, §§ 2, 5, 8, 11, repealed. Sections 2, 5, 8 and 11 of chapter 522 of the private and special laws of 1885 are hereby repealed.

Sec. 2. P. & S. L., 1887, c. 9, §§ 1, 2, repealed. Sections 1 and 2 of chapter 9 of the private and special laws of 1887 are hereby repealed.

Sec. 3. P. & S. L., 1905, c. 11, § 1, repealed. Section 1 of chapter 11 of the private and special laws of 1905 is hereby repealed.

Sec. 4. P. & S. L., 1913, c. 185, § 3, amended. Section 3 of chapter 185 of the private and special laws of 1913 is hereby amended by striking out all of said section and inserting in place thereof the following:

'Sec. 3. Water company may issue bonds. Said water company is hereby authorized and empowered to issue its bonds in such an amount or amounts as shall be necessary and convenient for the conduct of its business and secure the same by mortgage or deed of trust of all or any part of its property, franchises, rights and privileges now owned or to be hereafter acquired, with such provisions and on such terms and conditions, rates and times as it may determine for its corporate purposes; provided, however, that the issue of said bonds shall be subject to the provisions of section 41 of chapter 62 of the revised statutes and acts amendatory thereof.'

Sec. 5. P. & S. L., 1925, c. 6, § 1, amended. Section 1 of chapter 6 of the private and special laws of 1925 is hereby amended by striking out all of said section and inserting the following in lieu thereof:

'Sec. 1. Water company may increase capital stock. The Camden and Rockland Water Company, a corporation created by special act of the legislature, and charged with the performance of a public duty, is hereby
