a tax shall be levied. Whenever the inhabitants of 2 counties shall unite for organization in one farm bureau the amount of the tax assessed upon each county shall be in the proportion which the number of farm bureau members in that county bears to the total number of members in the 2 counties so united.'

Chapter 24

AN ACT Relating to Ministerial and School Funds.

Be it enacted by the People of the State of Maine, as follows:

Administration of ministerial and school funds. The ministerial and school funds now held in trust by any town or by a corporation existing under the provisions of section 51 of chapter 20 of the revised statutes may be turned over to the treasurer of state to be administered in accordance with the terms and provisions of such trust and which shall be invested by him in the same manner as provided for investments in securities enumerated in subsections I to X, both inclusive, of section 27 of chapter 57, as amended; such town or corporation thereupon shall be relieved of any further duties or liabilities for such funds, provided such town, acting under an appropriate article in the warrant at any annual town meeting, shall vote to cause such funds to be entrusted to the treasurer of state as aforesaid.

Chapter 25

AN ACT Providing for the Administration and Control of Baxter State Park.

Be it enacted by the People of the State of Maine, as follows:

P. L., 1939, c. 6, §§ 2, 3, amended. Sections 2 and 3 of chapter 6 of the public laws of 1939 are hereby repealed and the following sections inserted in place thereof:

'Sec. 2. **Control and management of lands.** All the lands in townships 3, 4 and 5, range 9 W. E. L. S. and in townships 3, 4 and 5, range 10 W. E. L. S. Piscataquis county, that have been donated and conveyed to

the state of Maine in trust by Percival Proctor Baxter and all lands in said townships 3, 4 and 5, range 9 and in townships 3, 4 and 5, range 10 and all lands in Piscataquis and Penobscot counties that hereafter shall be donated and conveyed to the said state by said Baxter in trust for state forest, public park and public recreational purposes shall be under the joint supervision and control of, and shall be administered by the state forest commissioner, the commissioner of inland fisheries and game and the attorney general and the said commissioners and attorney general shall have full power in the control and management of the same.'

'Sec. 3. Name of lands. All the lands described in section 2 of this act in townships 3, 4 and 5, range 9 W. E. L. S. and in townships 3, 4 and 5, range 10 W. E. L. S. Piscataquis county that have been donated and conveyed to the state of Maine in trust by Percival Proctor Baxter, and all lands in said townships 3, 4 and 5, range 9, and in townships 3, 4 and 5, range 10 and all lands in Piscataquis and Penobscot counties that hereafter shall be donated and conveyed to the said state by said Baxter in trust for state forest, public park and public recreational purposes are hereby named and shall hereafter be named "Baxter State Park" in honor of the donor, and the same hereafter shall forever be so designated on the official maps and records of the state.'

Chapter 26

AN ACT Relating to Katahdin Wild Life Sanctuary, Formerly Called
Katahdin Game Preserve, and Enlarging Same.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 38, § 90, amended. That portion of section 90 of chapter 38 of the revised statutes, relating to "Katahdin Game Preserve" as amended by chapter 5 of the public laws of 1939, is hereby repealed and the following enacted in place thereof:

'Katahdin Wild Life Sanctuary: the following described tract or territory situated in the county of Piscataquis, the same being in unorganized townships, to wit:

Townships 3, 4 and 5 in the 9th range W. E. L. S. and townships 3, 4 and 5 in the 10th range W. E. L. S. bounded as follows:

Commencing at the northeast corner of township 5 range 9 on the easterly line of the county of Piscataquis; thence southerly along the easterly line
