

RATIFICATION OF INCORPORATION LODGE NO. 12, K. OF P. 425 CHAP. 15

Chapter 14

AN ACT Authorizing Penobscot County Water Company to Obtain and Maintain a Supply of Water for Its Corporate Purposes.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. May increase water storage. Penobscot County Water Company for the purpose of obtaining and maintaining a supply of water for its corporate purposes is hereby authorized and empowered to increase the storage of any stream, lake, or pond tributary to its present source of water supply and to erect and maintain all proper structures therefor.

Sec. 2. May take land, etc. For the aforesaid purposes Penobscot County Water Company is hereby authorized and empowered to take and hold by purchase or otherwise including by right of eminent domain any land or interest therein or water rights necessary for erecting dams for flowage, for reservoirs, for preserving the purity of the watershed and/or for laying and maintaining pipes, aqueducts, and other structures for taking, distributing, discharging, and disposing of water.

Sec. 3. Procedure. In exercising any right of eminent domain hereunder the proceedings and procedure therefor and for the determination of damages occasioned thereby shall be the same as provided in sections 12 to 22 both sections inclusive of chapter 69 of the revised statutes or as the same may be amended.

Sec. 4. Limitation. This act shall not be construed as in any way limiting the existing powers and/or franchises of the Penobscot County Water Company but shall be in addition thereto.

Chapter 15

AN ACT to Ratify and Make Valid the Incorporation of Riverside Lodge No. 12, Knights of Pythias.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Incorporation of Riverside Lodge No. 12, Knights of Pythias ratified and made valid. The incorporation of Riverside Lodge No. 12, Knights of Pythias at Sanford in the county of York, on January 3, 1899 in accordance with the provisions of the statutes of Maine in such cases

made and provided, is hereby ratified, affirmed and made valid, and all acts and doings of its members and officers, acting as a body corporate, hereby are declared to be of the same full, complete and binding force and effect as such acts and doings would have been had the president and treasurer and majority of the directors of said corporation within 60 days after organization prepared a certificate setting forth the name and purposes of incorporation, the town where located, the number and names of the officers, and had signed and made oath to it and filed the same in the office of the secretary of state in accordance with the provisions of chapter 192 of the public laws of Maine, 1897.

Sec. 2. Transfers of documents, etc., made valid. All conveyances, transfers and other documents in writing heretofore executed by the officers of said organization as a body corporate for and in the name of Riverside Lodge No. 12, Knights of Pythias are hereby declared to be valid and binding upon the corporation. All conveyances, grants and transfers of title of property, real and personal, heretofore made to said Riverside Lodge No. 12, Knights of Pythias as a corporation are hereby declared to be valid.

Sec. 3. Copy of act to be recorded. A copy of this act, certified by the secretary of state, shall be filed in the office of the secretary of state and in the office of the registry of deeds for the county of York, and shall be recorded in the records of the secretary of state and of said registry of deeds in the same manner as certificates of incorporation are recorded.

Chapter 16

AN ACT to Extend the Charter of the Patten Water and Power Company.

Be it enacted by the People of the State of Maine, as follows:

Extension of powers. The rights, powers and privileges granted by chapter 47 of the private and special laws of 1923 are hereby extended for a term of 2 years from the time when the same would otherwise expire.
