

**CHAP. 32** 

#### Chapter 31

#### AN ACT Relating to the Raymond Fish Hatchery.

Be it enacted by the People of the State of Maine, as follows:

- Sec. I. Agreement cancelled. The commissioner of inland fisheries and game is hereby authorized to cancel the agreement entered into between Nellie M. Gifford, of Haddonfield, New Jersey and the state of Maine under date of August I, 1903, under which agreement the state has heretofore maintained the Raymond Fish Hatchery Station on lands belonging to said Gifford.
- Sec. 2. New lease to be secured. Before said agreement is cancelled the said commissioner shall secure from the said Nellie M. Gifford a new lease in the name of the state of Maine for the use of such lands, water supply and other riparian rights and privileges as the said commissioner may deem necessary for the use of said fish hatchery. Said lease shall be for such term of years and provide for such annual rental to be paid by the state as may be mutually agreed upon, provided, however, that such rentals shall not exceed \$200 per year in addition to any obligations assumed by the state as to the maintenance of the premises.

### Chapter 32

#### AN ACT Relating to Salaries of Municipal Court of Bath.

Be it enacted by the People of the State of Maine, as follows:

- P. & S. L., 1937, c. 64, amended. That part designated 'Sec. 2.' of chapter 64 of the private and special laws of 1937 is hereby amended to read as follows:
- 'Sec. 2. Qualifications of judge and recorder; salary. Said judge and recorder shall be members of the bar of Sagadahoc county, and shall reside during their continuance in office in said county. The judge of said court shall receive from the county of Sagadahoc an annual salary of \$1450 \$1650 to be paid to him in quarterly payments. Said recorder shall receive from the county of Sagadahoc an annual salary of \$500 \$600 to be paid to him in quarterly payments. Both salaries shall be in full for all fees and emoluments of their respective offices.'
