Supplementary to Private and Special Acts of 1941

Chapter 96

AN ACT Changing the Name of Northern Finance and Investment Corporation to "M-A-C Plan of NE".

Be it enacted by the People of the State of Maine, as follows:

Name of "Northern Finance and Investment Corporation" changed. The corporation now known as the "Northern Finance and Investment Corporation" shall hereafter be known as "M-A-C Plan of NE". All rights, powers, duties and liabilities of "Northern Finance and Investment Corporation" shall be exercised and performed by or imposed upon "M-A-C Plan of NE". Nothing herein is intended to repeal any part of the existing statute, except the name of "Northern Finance and Investment Corporation".

Chapter 97

AN ACT Providing for Transfer of Certain State Property to the Maine Nautical Training School or Maine Maritime Academy.

Emergency preamble. Whereas, a state of war exists between the United States and Germany, Italy, Japan and other foreign countries; and

Whereas, in the judgment of the legislature this fact creates an emergency within the meaning of section 16 of Article XXXI of the constitution of Maine and requires the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1941, c. 37, additional. Chapter 37 of the private and special laws of 1941 is hereby amended by adding thereto a new section to be numbered section 6, and to read as follows:

'Sec. 6. Transfer of property authorized. The board of normal school trustees is authorized to discontinue the use of Eastern State Normal School as an elementary teacher training institution when and if, in the judgment of the said board, the enrolment reaches the point where the maintenance of the school is no longer considered to be educationally profitable.
