Supplementary to Private and Special Acts of 1941

#### AMENDING CHARTER OF LEWISTON

65 CHAP. 98

therewith hitherto occupied by the Eastern State Normal School, and not essential to other teacher training institutions, may be leased to the Maine Maritime Academy for such period of time and for such rental, not less than \$1 per year, as may be agreed upon by the board of normal school trustees and the trustees of the Maine Maritime Academy; any such lease shall be executed on the part of the state of Maine by the chairman of the board of normal school trustees and on the part of the Maine Maritime Academy by the chairman of its board of trustees and shall contain a provision that the lessee shall keep the buildings adequately insured against fire, shall keep them in good repair and shall deliver them up to the state of Maine at the expiration of the term of such lease in as good condition as they were at the commencement thereof. Upon the execution and delivery of such a lease, at any time prior to the 30th day of June, 1943,  $\frac{1}{2}$  of the amount apportioned by the board of normal school trustees for the operation of the Eastern State Normal School for the fiscal year ending June 30, 1043, shall be transferred to the general funds of the state for the use of the Maine Maritime Academy as provided by law.'

**Emergency clause.** In view of the emergency cited in the preamble, this act shall take effect when approved.

### Chapter 98

#### AN ACT Amending the Charter of the City of Lewiston.

**Emergency preamble.** Whereas, the police officers of the city of Lewiston will be required to perform extra duties because of the war emergency; and

Whereas, the city of Lewiston cannot properly compensate the said officers for said services without action of the legislature; and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of section 16 of Article XXXI of the constitution of Maine, and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1939, c. 8, Art. XI, § 14, amended. Section 14 of Article XI of chapter 8 of the private and special laws of 1939 is hereby amended to read as follows:

#### 66 GOVERNOR'S FACSIMILE SIGNATURE ON STATE BONDS CHAP. 99

'Sec. 14. Salary and vacation of chief. The salary of the chief of police shall be  $\$_{2,100}$   $\$_{3,000}$  per annum, payable in equal weekly installments by the city treasurer. He shall be entitled to 2 weeks' vacation each calendar year with pay, to be taken when and as he may desire. While upon vacation, or when incapacitated through illness, or absent from his office on the business of the department, the duties of his position shall be assumed by the senior captain.'

Sec. 2. P. & S. L., 1939, c. 8, Art. XI, § 17, amended. Section 17 of Article XI of chapter 8 of the private and special laws of 1939 is hereby amended to read as follows:

'Sec. 17. Certain fees to be accounted for. All fees paid to the chief of police, captains, inspectors, police matron or any patrolman in their said capacities, from cases in the Lewiston municipal court, and all fees received for serving subpoenas in cases involving criminal procedure in the superior court held in the county of Androscoggin, shall be accounted for by such officers, and turned into the treasury of the city of Lewiston when received by them.'

### Chapter 99

### AN ACT Authorizing the Facsimile of the Signature of the Governor to be Used on Bonds Issued by the State.

**Emergency preamble.** Whereas, a state of war exists between the United States and Germany, Italy, Japan and other foreign countries; and

Whereas, in the judgment of the legislature this fact creates an emergency within the meaning of section 16 of Article XXXI of the constitution of Maine and requires the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1941, c. 68, § 3, amended. Section 3 of chapter 68 of the private and special laws of 1941 is hereby amended to read as follows:
