## Chapter 6

### RESOLVE, Regulating Fishing in Pierce Pond in Somerset County.

**Fishing in Pierce pond; regulated. Resolved:** That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening Pierce pond in Bowtown and Pierce Pond townships, county of Somerset, to fly-fishing only from the dam at the outlet of said pond to Gull Rock, and to fly-fishing and trolling with flies only in Middle and Upper Pierce ponds from Caribou Narrows to head of Upper Lake until July 1st of each year, thereafter, open under general laws.

## Chapter 7

### RESOLVE, Regulating Fishing in Lincoln County.

**Fishing in Lincoln county, regulated. Resolved:** That the commissioner of inland fisheries and game, be and hereby is, directed to issue a rule and regulation, establishing April 1st as the opening date for fishing in Lincoln county.

## Chapter 8

### RESOLVE, in Favor of Horace Polchies, Representative of the Penobscot Tribe of Indians.

**Horace Polchies; appropriation for. Resolved:** That there be, and hereby is, appropriated, to be paid to Horace Polchies, representative of the Penobscot tribe of Indians at the 90th legislature, the sum of \$200 for attendance, and \$18 for mileage; said sums to be paid immediately in full from the appropriation for legislative expenses.
