## Chapter 19

### RESOLVE, Regulating Fishing in Cumberland and York Counties.

Fishing in Cumberland and York counties, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation establishing a minimum length of 6 inches on trout taken from all rivers above tide-water in Cumberland and York counties.

## Chapter 20

### RESOLVE, Regulating Fishing in Alford's Lake and Lermond's Pond.

Fishing in Alford's lake and Lermond's pond, regulated. Resolved: That the commissioner of inland fisheries and game, be and hereby is, directed to issue a rule and regulation opening Alford's lake and Lermond's pond, in Hope, county of Knox, to ice fishing for pickerel, white perch, hornpout, yellow perch, eels, cusk, chubs and smelts from the time the ice forms in the fall until it goes out in the spring.

## Chapter 21

### RESOLVE, Regulating Fishing in Certain Waters.

Fishing in certain waters; regulated. Resolved: That the commissioner of inland fisheries and game, be and hereby is authorized and directed to issue a rule and regulation making the daily bag limit of 3 fish to be taken from the following waters:

Rangeley lake, located in the town of Rangeley, Rangeley plantation and Sandy River plantation, county of Franklin;

Mooselucmeguntic lake, located in the town of Rangeley, Rangeley plantation, Richardson and Adamstown (T. 4, R. 2), counties of Oxford and Franklin;

Cupsuptic lake, located in Adamstown (T. 4, R. 2), Rangeley and Lower Cupsuptic towns, counties of Franklin and Oxford.
