## Chapter 28

### RESOLVE, Regulating Fishing in Roaring Brook Pond.

Fishing in Roaring Brook pond, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation opening to ice fishing for pickerel only, from the time the ice forms in the fall until it goes out in the spring, Roaring Brook pond in township 7, range 9, county of Piscataquis.

## Chapter 29

### RESOLVE, Regulating Fishing in Hasting Pond.

Fishing in Hasting pond, regulated. Resolved: That the commissioner of inland fisheries and game, be and hereby is, directed to issue a rule and regulation closing to all except fly fishing Hasting pond in Bristol, county of Lincoln, and establishing a daily limit of 5 fish per person on the same.

## Chapter 30

### RESOLVE, Regulating Fishing in Ross Pond.

Fishing in Ross pond, regulated. Resolved: That the commissioner of inland fisheries and game be, and hereby is, directed to issue a rule and regulation, establishing a daily limit, on Ross pond in Bristol, county of Lincoln, of 5 fish per person.

## Chapter 31

### RESOLVE, Regulating Fishing in Chase's Mill Stream.

Fishing in Chase's Mill stream, regulated. Resolved: That the commissioner of inland fisheries and game, be and hereby is, directed to issue a rule and regulation, closing Chase's Mill stream in East Machias, county of Washington, to the taking of fish, except that fish may be taken with a rod and line under the general law.
