## Chapter 32

**RESOLVE, Granting Authority to the Forestry Department to Convey Certain Land to Stanley Hinch, of Danforth.**

Forestry department authorized to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey the interest of the state in the following described lot to Stanley Hinch, of Danforth, for the sum of \$122.59: 1/144 of 23,640 acres of land in T. 2, R. 9, W. E. L. S., Piscataquis county.

## Chapter 33

**RESOLVE, Granting Authority to the Forestry Department to Convey Certain Land to J. C. Briggs, of Caribou.**

Forestry department authorized to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey the interest of the state in the following described lot to J. C. Briggs, of Caribou, for the sum of \$74.03: a 26 acre parcel of land in T. 17, R. 4, W.E.L.S., Aroostook county.

## Chapter 34

**RESOLVE, Authorizing the Forest Commissioner to Convey Certain Land to Maxime Albert of Sinclair.**

Forest commissioner to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey to Maxime Albert of Sinclair, the interest of the state in 58 acres in 168 acre parcel of land with buildings thereon in T. 17, R. 4, W. E. L. S., Aroostook county, for the sum of \$86.89.
