## Chapter 76

RESOLVE, in Favor of Mrs. Albertha Williams, of Bath.

Mrs. Albertha Williams; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$300 to be paid to Mrs. Albertha Williams, of Bath, as a full and final settlement of all claims against the state for damage to her land and house occasioned by raising the grade of a road; said sum to be paid from the general highway funds.

## Chapter 77

RESOLVE, in Favor of Mrs. Estella M. Littlefield, of Hampden.

Mrs. Estella M. Littlefield; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$400 to be paid to Mrs. Estella M. Littlefield, of Hampden, as a full and final settlement of all claims against the state for damage done to her property by the natural course of a stream being changed by the building of a diversion dam in the process of building a fishway, on Sourdabscook stream; said sum to be paid from the funds of the inland fisheries and game department.

## Chapter 78

RESOLVE, in Favor of Inez T. Fogg, of Readfield.

Inez T. Fogg; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$1000 to be paid to Inez T. Fogg, of Readfield, as a full and final settlement of all claims against the state for damage to her motor vehicle, hospital and medical expenses, and personal injuries to her person and damages arising out of injuries caused by a collision between her automobile and a moose; said sum to be paid from the funds of the department of inland fisheries and game.
