## Chapter 85

### RESOLVE, Authorizing the Forest Commissioner to Convey Certain Land in Perkins Plantation.

Conveyance of certain state land; authorized. Resolved: That the forest commissioner be, and hereby is, authorized to convey to John F. Blanchard, of Dryden, for the sum of \$321.82, whatever interest the state may have in the following described property in Perkins Plantation, to wit:

60 acres in 159 acres in Lot 1, R. 5; 150 acres in 160 acres in Lot 2, R. 5; 20 acres in 160 acres in Lot 1, R. 6; 100 acres in 160 acres in Lot 3, R. 6; 73 acres in 160 acres in Lot 2, R. 6.

## Chapter 86

### RESOLVE, in Favor of Vernon A. Soule.

Vernon A. Soule; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$1,000 to be paid to Vernon A. Soule, of Augusta, as a full and final settlement of all claims against the state, for the loss of his Stinson airplane which was stored in the state hangar at the Augusta State Airport, and was destroyed by fire, together with said hangar on February 9, 1938; said sum to be paid from the general state funds.

## Chapter 87

### RESOLVE, in Favor of Zina N. Witham.

Zina N. Witham; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$500 to be paid Zina N. Witham, of Augusta, as a full and final settlement of all claims against the state for the loss of a Moth airplane, which was stored in the state hangar at the Augusta State Airport, and was destroyed by fire, together with said hangar, on February 9, 1938; said sum to be paid from the general funds of the state.
