## Chapter 96

**RESOLVE, in Favor of a Pension for Lena Butler Richards.**

Lena B. Richards; pension for. Resolved: That a pension be, and hereby is, granted to Lena Butler Richards, of St. Albans, to be paid quarterly from the appropriation for teachers' pensions. Said pension shall begin 90 days after adjournment of the legislature and shall continue until otherwise provided by the legislature.

## Chapter 97

**RESOLVE, Authorizing the Forest Commissioner to Convey Certain Land to Fred McGeorge, of East Machias.**

Forest commissioner authorized to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey to Fred McGeorge of East Machias, whatever interest the state may have in lot 120 containing 160 acres in 18 East Division, Washington county, for the sum of \$157.59.

**RESOLVE, in Favor of Olaf Nylander.**

Olaf Nylander; compensated. Resolved: That there be, and hereby is, appropriated the sum of \$500 to be paid to Grover Hardison, town manager, in the town of Caribou, as trustee for Olaf Nylander, of Caribou, in trust for the purpose of paying Olaf Nylander's hospital bill; said sum to be paid from the general funds of the state.
