## Chapter 107

### RESOLVE, for Screening Sennebec Pond at Union.

Sennebec pond at Union; screening of. Resolved: That Luther Barker, and such other persons as may join with him, are hereby authorized to build a fish screen at the outlet of Sennebec pond in Union, in the county of Knox; provided, however, that there shall be no liability on the state for the maintenance or repair of said screen.

## Chapter 108

### RESOLVE, Granting Authority to the Forestry Department to Convey Certain Land to Stanley Hinch, of Danforth.

Forestry department authorized to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey the interest of the state in the following described lot to Stanley Hinch, of Danforth, for the sum of \$125.30: 1/6 of 960 acres of the Reserved Lands in T. 7, R. 7, W. E. L. S., Penobscot county.

## Chapter 109

### RESOLVE, Authorizing the Forest Commissioner to Convey Certain Lands to Estate of Isaac Bragg.

Forest commissioner authorized to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to sell and convey to the estate of Isaac Bragg, the interest of the state in the southeast quarter of township 18, range 12, W. E. L. S. in Aroostook county according to survey and plan of said township as returned to the state land office by Small & Barker in 1845, exclusive of the public lot; together with the right to cut and carry away the timber and grass on the reserved lands in said southeast quarter, for the sum of \$1630.42.
