CHAP. 139

Town of Trescott, for burial expenses of Aaron Mooers, a pauper	\$ 100.00
Town of Veazie, for burial expenses of Daisy E. Russell, a pauper	100.00
Town of Windham, for board and care of Sawyer children, paupers	72.56
Town of Winterport, for support of Maurice Stillman and family, paupers	851.07
Town of Woodland, for expenses incurred by Walter Wood, a pauper	285.80

Chapter 138**RESOLVE, in Favor of the Children's Aid Society.**

Children's Aid Society; reimbursed. Resolved: That there be, and hereby is, appropriated the sum of \$558 to be paid to the Children's Aid Society to reimburse the said society for care of 6 girls during the year beginning June 1, 1939 and ending June 1, 1940; said sum to be paid from the general funds of the state.

Chapter 139**RESOLVE, Authorizing the Improvement of Fort Knox Reservation.**

Improvement of Fort Knox Reservation authorized. Resolved: That the forest commissioner is hereby authorized and directed to sell so much of the timber from the Fort Knox Reservation in the town of Prospect as will not detract from the beauty of the scenery.

The timber shall be sold to the highest bidder under such regulations as the commission shall issue, provided, however, that the commissioner may reject all bids that do not offer a reasonable market price for such timber.

The proceeds from such sale shall be expended under the direction of such commissioner in building a suitable road on the reservation property from the state highway to the granite wharves on the reservation on the Penobscot river; and in building fireplaces, tables and shelters, and providing other facilities for picnic parties and the general public on the reservation, and in restoring the various parts of the fort to as good condition as possible with the funds available and pay such other expenses in connection therewith as may be necessary.
