(Effective July 26, 1941)

Chapter 142

RESOLVE, Permitting the Use of the Eastern State Normal School Plant as a Nautical Training School.

Eastern State Normal School may be used for purposes of a nautical training school. Resolved: That the state normal school board be, and hereby is, authorized to lease on behalf of the state to the "Maine Nautical Training School" so much of the plant at the Eastern State Normal School at Castine (including the grounds and the buildings thereon, and the fixtures and personal property therein or such part or so much of them as may be deemed advisable) as is not used for the purposes of the normal school for such term or terms of years and for such consideration as the said board deems advisable for the purpose of maintenance of a nautical training school; provided, however, that any lease made under the provisions of this resolve shall be subject to the right of the state to terminate such lease by an act or resolve of the legislature.

Chapter 143

RESOLVE, Dividing the State into Executive Councillor Districts.

Apportionment executive councillor districts. Resolved: That for the years 1943 to and including the year 1952, the state is hereby divided into 7 councillor districts, each of which districts shall be entitled to 1 councillor to be chosen in the manner prescribed by the constitution and laws of the state, as follows:

First: York, 1943-44, 1945-46, 1951-52. Oxford, 1947-48, 1949-50.

Second: Cumberland, 1 for each year.

Third: Sagadahoc, 1943-44. Androscoggin, 1945-46, 1949-50, 1951-52. Franklin, 1947-48.

Fourth: Somerset, 1943-44, 1945-46. Kennebec, 1947-48, 1949-50, 1951-52.

Fifth: Lincoln, 1943-44. Waldo, 1945-46. Hancock, 1947-48, 1949-50. Knox, 1951-52.

Sixth: Piscataquis, 1943-44. Penobscot, 1945-46, 1947-48, 1949-50, 1951-52.

Seventh: Washington, 1943-44, 1945-46. Aroostook, 1947-48, 1949-50, 1951-52.

Approved April 25, 1941
