Chapter 145

RESOLVE, Providing Pensions for Soldiers and Sailors and Dependents and Other Needy Persons.

Pensions granted to certain soldiers and sailors and dependents and other needy persons. Resolved: That a pension be, and hereby is, granted to each of the persons hereinafter listed in the amounts set against their respective names, to be paid quarterly from a fund for pensions allowed by special legislative resolves. Said pensions shall begin on July 1, 1941, and shall continue until otherwise provided by the legislature, with the exceptions indicated herein.

Provided, however, that in all cases where the applicants are now receiving a state pension, other than old age assistance or aid to the blind, the amount named herein shall be in lieu thereof and not in addition thereto.

Chapter 146

RESOLVE, for the Construction, Maintenance and Repair of Roads and Bridges.

Construction, maintenance and repair of roads and bridges. Resolved: That there be and hereby is, appropriated the sum of \$150,000 for the fiscal period ending June 30, 1941 and \$150,000 for the fiscal period ending June 30, 1942 to aid in constructing, repairing and maintaining such highways and bridges as hereinafter specified, to be paid from the general highway fund as by special resolves. And there is further appropriated \$197,460 from the general highway fund to be paid to the towns as specified below. Provided, however, that no appropriation herein contained shall be available unless the town designated to receive the same shall undertake that all road material, including clay, gravel, sand and rock, necessary for the improvement contemplated by this resolve shall be furnished without expense to the state, and that each town shall assume and pay all damages whatsoever arising from the taking of land or from the change of grade, drainage or alignment deemed by the state highway commission
