Chapter 147

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Land in Aroostook County to John Parent of Hamlin Plantation.

Forest commissioner authorized to convey certain land. Resolved: That the forest commissioner be, and hereby is, authorized to convey to John Parent of Hamlin Plantation whatever interest the state has in lot 21 of the public lot in Hamlin Plantation (township G, range 1, W. E. L. S.), Aroostook county, which was sold to John Parent of Hamlin Plantation by W. C. Hammond of Van Buren by a warranty deed dated July 17, 1868.

Chapter 148

RESOLVE, in Favor of the Town of Durham.

Resolve in favor of the town of Durham, amended. Resolved: That that part of chapter 146 of the resolves of 1941, relating to the town of Durham be, and hereby is, amended to read as follows:

CHAP. 150

'Durham. To aid in ~~terring~~ the construction of state aid highway No. 1, beginning at Lisbon Falls town line and continuing in a southwesterly direction to the Freeport town line, a distance of approximately 5 miles

Chapter 149

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Lands of Hancock County to Orman B. Fernandez, Old Town, Maine.

Emergency preamble. Whereas, a state of war exists between the United States and Germany, Italy, Japan and other foreign countries; and

Whereas, the land maintained in this resolve is desired by the United States government for use as a bombing range; and

Whereas, it is necessary that the title be properly cleared in order that the government may obtain possession thereof; and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of section 16 of Article XXXI of the constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Forest commissioner authorized to convey certain land. Resolved: That the forest commissioner as land agent, be and hereby is, authorized to convey to Orman B. Fernandez, Old Town, Maine, the interest of the state in 113 acres of land in Township No. 32, Middle Division, Hancock county, for the sum of \$279.38.

Emergency clause. In view of the emergency cited in the preamble, this act shall take effect when approved.
