Chapter 107

AN ACT Increasing the Salary and Compensation of the State Police.

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 29, § 126, amended. The 1st 5 paragraphs of section 126 of chapter 29 of the revised statutes, as amended, are hereby further amended to read as follows:

'The governor and council shall determine the salary of the chief and deputy chief. The compensation of the other members of the state police shall be determined as follows:

On appointment as a patrolman, the member shall receive a salary of \$20 per week, for his probation period of 6 months, at the end of which time he shall receive a salary of \$25 per week for the next 6 months; during his 2nd year of service, he shall receive a salary of \$28 per week; during the next 6 years he shall receive a salary of \$32 a week; and thereafter, he shall receive an annual increase of \$1.50 per week until his pay shall reach the sum of \$35 per week.

On appointment as a trooper, the member shall receive a salary of \$25 per week for a period of 6 months and \$30 per week thereafter for the balance of the 1st year of service; during the 2nd year of service he shall receive a salary of \$32.50 per week; during the next 2 years he shall receive a salary of \$36 per week; and thereafter he shall receive a salary of \$40 per week.

On appointment as a sergeant, the member shall receive a salary of \$36 \$42.50 per week. ~~Annually each sergeant shall receive an increase in salary of \$26 per year until his pay shall reach the sum of \$38 per week.~~

On appointment as a lieutenant, the member shall receive a salary of \$40 \$47 per week. ~~Annually each lieutenant shall receive an increase in salary of \$1 per week until his pay shall reach the sum of \$45 per week.~~

On appointment as a captain, the member shall receive a salary of \$47 \$55 per week. ~~Annually each captain shall receive an increase in salary of \$1 per week until his pay shall reach the sum of \$53 per week.'~~
