Chapter 153

AN ACT Relating to Disposal of Confiscated Ammunition and Small Arms.

Be it enacted by the People of the State of Maine, as follows:

Disposal of confiscated ammunition and small arms. The state police, the department of inland fisheries and game, the sheriff of any county, and the police department of any city are hereby empowered to loan, without charge, to the adjutant-general's department of the state for the use of the state's military or naval forces all small arms and ammunition which have been or may be confiscated for violation of law.

Chapter 154

AN ACT to Define the Meaning of the Word "Municipality."

Be it enacted by the People of the State of Maine, as follows:

R. S., c. 1, § 6, additional. Section 6 of chapter 1 of the revised statutes, as amended, is hereby further amended by the addition thereto of a new paragraph to be numbered XIX-A and to read as follows:

'XIX-A. The word "municipality" includes cities, towns, and plantations.'

Chapter 155

AN ACT Relating to Examination and Registration of Osteopathic Physicians.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., c. 21, § 62, amended. Section 62 of chapter 21 of the revised statutes is hereby amended to read as follows:

'**Sec. 62. Osteopaths to be registered.** Any person, before engaging in the practice of osteopathy in this state, shall make application for a certificate to practice osteopathy to the board of osteopathic examination and registration, on a form prescribed by said board. Said application shall be filed with the secretary of the board, at least 7 days before the date of ex-
