## Chapter 14

### AN ACT Authorizing the Conveyance of "Baring Cemetery" to the "Baring Cemetery Corporation".

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. Conveyance of "Baring Cemetery" to the "Baring Cemetery Corporation" by the state, authorized. The state tax assessor is hereby authorized to convey by quitclaim deed to the "Baring Cemetery Corporation", all the right, title and interest that the state of Maine may have in the "Baring Cemetery" so called, located in the deorganized town of Baring, in the county of Washington.

Sec. 2. Certain provisions of law not to apply to "Baring Cemetery". The provisions of section 5 of chapter 24 of the revised statutes shall not apply to the "Baring Cemetery".

## Chapter 15

### AN ACT to Clarify the Purposes of United Baptist Convention of Maine.

*Be it enacted by the People of the State of Maine, as follows:*

P. & S. L., 1915, c. 114, amended. Chapter 114 of the private and special laws of 1915 is hereby amended by adding thereto a new section to be numbered 12, and to read as follows:

'Sec. 12. Corporate purposes. The corporate purposes of said United Baptist Convention of Maine are, and shall be religious and charitable, and not for profit, and shall be exercised within the scope of the denomination it represents, to diffuse Christian knowledge, to foster religious education, to organize new churches and assist churches, to promote domestic and foreign missions, to stimulate evangelistic effort, to give aid to its ministers and their widows, to assist persons in obtaining education to enter the

ministry, to promote a better union and cooperation between the churches and associations in this state, and to give expression to the opinions of its constituency upon moral, religious, social and denominational matters.

The aforesaid purposes include all the purposes of the several formerly existing organizations which by merger or affiliation are now included in United Baptist Convention of Maine or to which it has succeeded.'

## Chapter 16

AN ACT Relating to the Appropriation for and Assistance to the Maine Maritime Academy.

*Be it enacted by the People of the State of Maine, as follows:*

Sec. 1. P. & S. L., 1941, c. 37, § 4, amended. Section 4 of chapter 37 of the private and special laws of 1941, as amended by section 4 of chapter 102 of the private and special laws of 1941, is hereby further amended to read as follows:

'Sec. 4. State aid. In addition to the income provided by the provisions of section 3, ~~there is hereby appropriated the sum of \$100,000 biennially~~ from such sums as shall be appropriated biennially for the operation of the school the treasurer of state or his successor shall, upon request of the trustees, make ~~advances~~ grants for ~~the~~ such operation of the school ~~not to exceed \$50,000 per annum~~ to the treasurer of the school, who shall give bond in an amount to be set by the governor and council, but not less than \$15,000 with sureties approved by the governor and council, for its proper disbursement.'

Sec. 2. P. & S. L., 1941, c. 37, § 6, amended. Section 6 of chapter 37 of the private and special laws of 1941, as enacted by section 5 of chapter 102 of the private and special laws of 1941, is hereby amended by adding at the end thereof a new paragraph to read as follows:

'Every department and agency of the state, when requested, may furnish such assistance, counsel, or advice as the trustees may require in the discharge of their duties.'
