Chapter 45

AN ACT Relating to the Salary of the Recorder of the Sanford Municipal Court.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1915, c. 39, § 2, amended. Section 2 of chapter 39 of the private and special laws of 1915, as amended, is hereby further amended to read as follows:

'Sec. 2. Salary increased. The recorder of the Sanford municipal court shall receive as compensation, an annual salary of ~~\$800~~ \$1,000, payable quarterly, on the 1st days of January, April, July and October, from the county treasury of the county of York. All fees received by him shall be paid over to the county treasurer.'

Chapter 46

AN ACT to Amend the Act Providing a Pension for Members of the Police and Fire Departments of the City of Waterville.

Be it enacted by the People of the State of Maine, as follows:

P. & S. L., 1941, c. 88, § 4, amended. Section 4 of chapter 88 of the private and special laws of 1941 is hereby amended by adding at the end thereof the following paragraph:

'6. Any regular member reaching the age of 65 before the effective date of this act and continuing to serve until the effective date of this amendment shall be entitled to the pension set out in this act upon his honorable discharge as set out in this section provided he has substantially complied with the provisions of section 6.'

Chapter 47

AN ACT to Amend the Charter of the City of Auburn.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. P. & S. L., 1917, c. 201, Art. II, § 4, amended. Section 4 of Article II of chapter 201 of the private and special laws of 1917, is hereby repealed and the following enacted in place thereof:
