Chapter 37

RESOLVE, Authorizing the Forest Commissioner to Convey Certain Interest of the State in Lands in Somerset County to George H. Cook, Jr., and Howard H. Chase.

Forest commissioner authorized to convey certain lands. **Resolved:** That the forest commissioner be, and hereby is, authorized to convey to George H. Cook, Jr., and Howard H. Chase, both of Leominster, Massachusetts, in equal shares, whatever interest the state has in lots 87, 88 and 89 in Big W, N. B. K. P., containing 22 acres, more or less, for the sum of \$1,208.36.

Chapter 38

RESOLVE, Relating to the Completion of the Eighth Revision of the General and Public Laws.

Completion of revision of statutes. **Resolved:** That a joint select committee consisting of 2 members of the senate to be appointed by the president of the senate and 3 members of the house of representatives to be appointed by the speaker of the house, be and is hereby created for the purpose of completing the eighth revision of the general and public laws of the state, incorporating therein the public laws enacted by the 91st legislature; correcting the notes and annotations of sections to correspond with the final draft of the revision; preparing notes and references to new sections; adding references to all appropriate cases reported in the Maine reports; and to report a final draft of such revision in print, and be it further

Resolved: That the committee shall supplement the final draft herein provided for with a suitable, comprehensive index, and be it further

Resolved: That the revisor of statutes is hereby directed to prepare a report on a revision of the statutes, consolidating all the general and public laws now in force and such as may be enacted at the present session of the legislature in language concise and intelligible and of the same intent, effect and construction, omitting from said report all such statutes and acts as have been repealed or superseded, and arranging the chapters and sections of the revision so that relative subject matter will be contiguous as far as possible, adding references to all decisions interpreting the statutes which appear in the Maine reports, correcting the notes, annotations and

citations of all chapters and sections, and preparing notes and references for new sections; and in addition shall prepare a cross reference table showing where the sections and chapters of the 1930 revision and laws amendatory thereof appear in the new revision, and be it further

Resolved: That the said committee on revision is hereby authorized to employ such assistance as may be necessary to expedite the completion of this revision and approve for payment the expense of the preliminary printing and such extra expenses as may be incurred by said revisor in preparing the reported revision, and be it further

Resolved: That the governor and council provide for the printing and binding of the report of the said committee, submitting the final draft of the revision of the public laws of the state, and for the printing and binding, as soon as may be after the enactment thereof, of 5,500 copies of the revised statutes of the state with the constitution thereof, the constitution of the United States, the repealing act, the cross reference tables, and the index prepared under the provisions of this resolve. Said revised statutes shall be bound in such style as to size of volumes, page, width of margin, printing, paper and binding as may be approved by the governor and council, and be it further

Resolved: That the governor and council may fix the retail price at which the statutes so published shall be sold, at a price of not less than \$15.00 per set, and the revenue from said sales shall be deposited to the credit of the general funds of the state of Maine, and be it further

Resolved: That the secretary of state shall secure the copyright of said volume or volumes for the use of the state and that the title to the annotations and the index contained in said volume be and remain the property of the state, and be it further

Resolved: That the state controller is hereby authorized to audit and cause payment to be made for the services and proper expenses of the committee, including compensation for such professional, expert and clerical assistants as may have been employed, and be it further

Resolved: That the unexpended balance appropriated for carrying out the provisions of chapter 140 of the resolves of 1941 shall be available for the purposes of this resolve, and that there be and hereby is appropriated the additional sum of \$10,000 for said purpose, and the unexpended balance at the close of any fiscal year shall be carried forward and not lapse until all conditions of this resolve and the said resolve of 1941 are fully met, and be it further

Resolved: That on completion of the revision the secretary of state shall furnish each member and officer of the 91st legislature one set of the new revised statutes, and be it further

CHAP. 41

Resolved: That this resolve pertaining solely to facilitating the performance of the business of the legislature and of a committee thereof, shall take effect upon approval.

Effective March 30, 1943

Chapter 39**RESOLVE, Relating to Old Legislative Publications.**

Librarian authorized to remove certain documents and records. Resolved: That the librarian of the Maine state library is hereby authorized to remove from the library reserve any excess copies of printed senate and house journals, legislative documents and legislative records, and to make such disposition of them as may seem proper; provided, however, that a sufficient number of each publication shall be retained to take care of the needs of the library and the legislature.

Chapter 40**RESOLVE, in Favor of a Bridge Across the Allagash River.**

Bridge to be constructed over Allagash river. Resolved: That the state highway commission be, and hereby is, authorized to build a wooden bridge across the Allagash river in Allagash Plantation, at or near the "present ferry site" in cooperation with the county of Aroostook and the plantation of Allagash under the provisions of the "Bridge Act", so called.

Effective July 9, 1943

Chapter 41**RESOLVE, Relating to Fire Protection for Baxter State Park.**

Appropriation for fire protection of Baxter State Park. Resolved: That there be, and hereby is, appropriated the sum of \$1,506 per year to be paid into the Maine Forestry District Fund to be used for the protection of Baxter State Park from fire.
