Chapter 59

RESOLVE, Providing Pensions for Soldiers and Sailors and Dependents and Other Needy Persons.

Emergency preamble. Whereas, a state of war exists between the United States and Germany and Japan, and

Whereas, the cost of living has increased greatly, and

Whereas, the people receiving aid from the state must have more assistance immediately in order to maintain themselves, and

Whereas, in the judgment of the legislature these facts create an emergency within the meaning of section 16 of Article XXXI of the constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it,

Pensions granted to certain soldiers and sailors and dependents and other needy persons. Resolved: That a pension be, and hereby is, granted to each of the persons hereinafter listed in the amounts set against their respective names, to be paid quarterly from a fund for pensions allowed by special legislative resolves. Said pensions shall begin on May 1, 1943, provided, however, that the 1st payment shall be for the period from May 1 to June 30, and shall continue until otherwise provided by the legislature, with the exceptions indicated herein.

Provided, however, that in all cases where the applicants are now receiving a state pension, other than old age assistance or aid to the blind, the amount named herein shall be in lieu thereof and not in addition thereto.

Chapter 60

RESOLVE, Providing for the Payment of Crop Damages Caused by Protected Wild Animals.

Damages caused by protected wild animals to crops, provided for. Resolved: That there be, and hereby is, appropriated the sum of \$1,698.28 from the appropriation for the department of inland fisheries and game to be paid to certain persons as set against the following names as a full and final settlement for their claims against the state for damages to their crops caused by protected wild animals, according to the following list:
